Your application was selected for review in a process called "Verification." The law says we have the right to ask you for this information before awarding Federal aid. If there are differences between your application information and your financial documents, EITC will make corrections electronically.

What you should do:

2. Complete and sign the worksheet.
3. Submit the completed worksheet, tax forms, and any other requested documents to the financial aid office.
4. EITC will compare information on this worksheet and any supporting documents with the information you submitted on your application.
