Your application was selected for review in a process called "Verification." In this process, EITC will be comparing information from your application with signed copies of your (and your spouse's, if you are married) 2010 Federal tax forms, W-2 forms, or other financial documents. The law says we have the right to ask you for this information before awarding Federal aid. If there are differences between your application information and your financial documents, EITC will make corrections electronically.

What you should do:

1. Collect your (and your spouse's) financial documents (signed Federal income tax forms, W-2 forms, etc.).
2. Complete and sign the worksheet.
3. Submit the completed worksheet, tax forms, and any other requested documents to the financial aid office.
4. EITC will compare information on this worksheet and any supporting documents with the information you submitted on your application.
