### Form Due to the Financial Aid Office by: April 15, 2016

Your 2016 Summer Award, (if any), will be based on your eligibility and attendance for the 2015-16 Academic Year. You must complete a 2015-2016 Free Application for Federal Student Aid, (FAFSA), if you have not already done so.

**ALL STUDENTS MUST REGISTER** for summer classes prior to submitting this form. We will determine your summer eligibility for financial assistance based on your enrolled, program eligible, credits. **We will not determine an award unless you are registered for summer classes.** If you change the number of credit hours you are enrolled in, please contact our office as your eligibility may change.

- **Pell:** If you were awarded the Federal Pell Grant for the 2015-2016 Academic Year and attended less than Full-Time for the Fall Semester and/or Spring Semesters, you **may** have Federal Pell Grant funds remaining to use for the Summer Semester tuition.
- **Loans:** Effective as of July 1, 2013, for all FIRST TIME borrowers: There is a limit on the maximum period of time, (measured in academic years), that you can receive Direct Subsidized Loans. In general, you may not receive Direct Subsidized Loans for more than 150% of the published length of your program. Eligibility for student loans will be determined by the Financial Aid Office. If you have not received the maximum loan amounts of your annual limits during the 2015-16 Award Year, then you may be eligible for a summer student loan. Students can only be awarded student loans up to the annual loan amounts allowable.
